On January 28-29, 2020, Diane Sullivan of the Tissue Resources Program staff conducted an on-site survey of the tissue banking activities at the following location:

During this time, the physical facilities and records of procurement, processing and distribution of semen from anonymous donors and client-depositors were reviewed along with storage records of reproductive tissue. No deficiencies were identified, no plan of correction required. Fairfax Cryobank, Inc. – Fairfax is in full compliance with Department regulations.

The license is effective until March 1, 2022. The certificate replaces that issued December 6, 2019. The certificate must be posted conspicuously at the approved location.

In accordance with the provisions of Section 52-3.7(d), the Department may request a summary of the activities of your tissue bank. Please report, in writing, any changes in tissue bank director and/or medical director within five (5) days of the change. Also, report changes in direct or indirect ownership within thirty (30) days and keep the Department informed of any relocation of the facility.
