RESULT: POSITIVE

This carrier test evaluated 514 gene(s) for genetic changes (variants) that are associated with an increased risk of having a child with a genetic condition. ABCA4-related conditions

A single Pathogenic variant, c.5642C>T (p.Ala1881Val), was identified in ABCA4.

What are ABCA4-related conditions?

ABCA4-related conditions are a spectrum of inherited retinal disorders that cause impaired vision.

Cone-rod dystrophy (CRD) typically presents during childhood or adolescence and symptoms become more severe over time. Symptoms include reduced visual acuity (farsightedness or nearsightedness), loss of color perception, increased sensitivity to light (photophobia), and difficulty seeing in low light settings (night blindness). Some affected individuals develop involuntary eye movements (nystagmus), and many are legally blind by mid-adulthood.

Stargardt disease typically presents during childhood to early adulthood, although the severity and progression are highly variable. Affected individuals experience symptoms including a dark spot appearing in the center of their vision, having difficulty reading, driving or recognizing faces, difficulty transitioning from an area of light to dark, and photophobia. Individuals can also develop problems with night or color vision over time. Upon retinal exam, there is a characteristic build up of an orange-yellow fatty substance called lipofuscin at the macula at the back of the eye, which is the part of the eye that is responsible for central vision.

Retinitis pigmentosa (RP) typically presents with night blindness, which usually occurs during childhood or adolescence. Vision loss continues over years or decades and typically progresses to a loss of side (peripheral) vision, causing tunnel vision. Ultimately, central vision loss occurs. Many individuals with RP are legally blind by adulthood, though the severity of symptoms and age of onset varies by individual.

Not everyone with a genetic change in ABCA4 will present the same; symptoms and severity can vary, even between family members with the same genetic change. Follow-up depends on each affected individual's specific situation, and discussion with a healthcare provider should be considered.

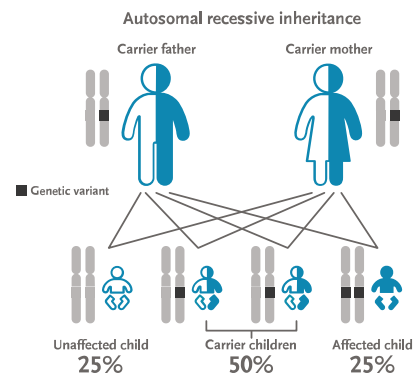

Cockayne syndrome A

A single Likely Pathogenic variant, c.399+1G>A (Splice donor), was identified in ERCC8.

What is Cockayne syndrome A?

Cockayne syndrome refers to a spectrum of conditions that affects several body systems. Cockayne syndrome can be caused by changes in different genes. Symptoms of Cockayne syndrome are progressive and typically include growth failure, a small head (microcephaly), and neurological problems that lead to developmental delay and intellectual disability. Other symptoms may include severe skin sensitivity to sun exposure (photosensitivity), eye defects, deafness, and skeletal and dental abnormalities. Prognosis is dependent upon the severity of symptoms, although life expectancy is typically reduced. On the mild end of the spectrum, some affected individuals may only have photosensitivity and perhaps mild neurological symptoms. This is also referred to as UV-sensitive syndrome; very few cases have been reported. On the severe end of the spectrum is a condition called cerebrooculofacioskeletal (COFS) syndrome. Symptoms of COFS begin prenatally and include prenatal growth failure, microcephaly, joint deformities that restrict movement of the hands and feet (arthrogryposis) and eye abnormalities, as well as developmental delay and intellectual disability. Individuals with COFS usually die within the first few years of life. Follow-up depends on each affected individual's specific situation, and discussion with a healthcare provider should be considered.

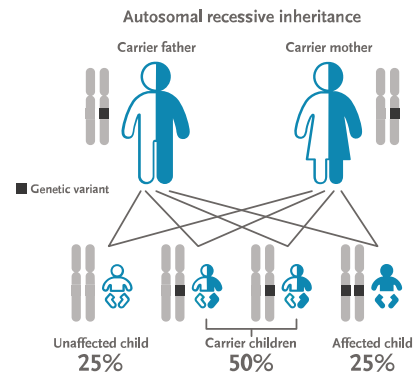

Polycystic kidney disease (PKHD1-related)

A single Pathogenic variant, c.10637del (p.Val3546Alafs*22), was identified in PKHD1.

What is polycystic kidney disease (PKHD1-related)?

Polycystic kidney disease (PKD) is part of the spectrum of conditions called ciliopathies, which involve defects in the microscopic, finger-like projections (cilia) that are located on the surface of cells and that are involved in cell movement and signaling. Ciliopathies affect many parts of the body. PKD can be caused by changes in different genes. Autosomal recessive polycystic kidney disease (ARPKD) is characterized by clusters of fluid-filled sacs (cysts) in the kidneys, which interfere with the kidneys' ability to filter waste products from the blood, leading to kidney dysfunction, enlargement (nephromegaly), and failure. Liver abnormalities may include cysts, an enlarged liver (hepatomegaly), and thickening and scarring of liver tissue that is present at birth (congenital hepatic fibrosis). Additional symptoms include high blood pressure (hypertension), dilated bile ducts, heart valve abnormalities, and underdeveloped fetal lungs during pregnancy. Age of onset, disease progression, and severity are variable. Approximately one third of affected individuals present prenatally or in infancy, one third in childhood, and one third present in adulthood. Some individuals with a single disease-causing PKHD1 variant (heterozygous carriers) have developed polycystic liver disease in adulthood (PMID: 28862642). Prognosis depends on the severity of symptoms. Life span is often reduced, although with treatment, many affected individuals survive into adulthood. Follow-up depends on each affected individual's specific situation, and discussion with a healthcare provider should be considered.

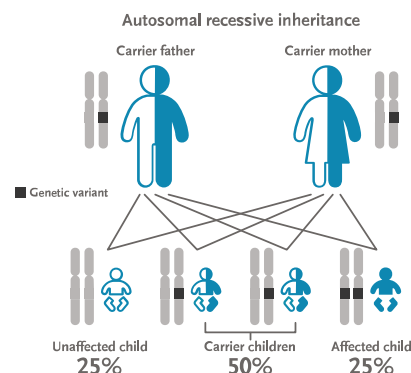

Results to note

GALT

- c.-119_-116del (Non-coding) was identified in the GALT gene.
- This benign variant is not known to cause disease and does not impact this individual's risk to be a carrier for galactosemia (GALT-related). Carrier testing for the reproductive partner is not indicated based on this result. See Variant details for more information.

SMN1

- Negative result. SMN1: 2 copies; c.*3+80T>G not detected.

Pseudodeficiency allele(s)

- Benign changes, c.1685T>C (p.Ile562Thr), known to be pseudodeficiency alleles, identified in the GALC gene. Pseudodeficiency alleles are not known to be associated with disease, including Krabbe disease.
- The presence of a pseudodeficiency allele does not impact this individual's risk to be a carrier. Individuals with pseudodeficiency alleles may exhibit false positive results on related biochemical tests, including newborn screening. However, pseudodeficiency alleles are not known to cause disease, even when there are two copies of the variant (homozygous) or when in combination with another disease-causing variant (compound heterozygous). Carrier testing for the reproductive partner is not indicated based on this result.

Variant details

ABCA4, Exon 40, c.5642C>T (p.Ala1881Val), heterozygous, PATHOGENIC

- This sequence change replaces alanine, which is neutral and non-polar, with valine, which is neutral and non-polar, at codon 1881 of the ABCA4 protein (p.Ala1881Val).
- This variant is present in population databases (rs369973540, gnomAD 0.02%).
- This missense change has been observed in individual(s) with Stargardt disease (PMID: 22661472, 30060493; Invitae). In at least one individual the data is consistent with being in trans (on the opposite chromosome) from a pathogenic variant.
- ClinVar contains an entry for this variant (Variation ID: 853893).
- Advanced modeling of protein sequence and biophysical properties (such as structural, functional, and spatial information, amino acid conservation, physicochemical variation, residue mobility, and thermodynamic stability) performed at Invitae indicates that this missense variant is expected to disrupt ABCA4 protein function with a positive predictive value of 80%.
- This variant disrupts the p.Ala1881 amino acid residue in ABCA4. Other variant(s) that disrupt this residue have been observed in individuals with ABCA4-related conditions (PMID: 26355662), which suggests that this may be a clinically significant amino acid residue.
- For these reasons, this variant has been classified as Pathogenic.

ERCC8, Intron 4, c.399+1G>A (Splice donor), heterozygous, Likely Pathogenic

- This sequence change affects a donor splice site in intron 4 of the ERCC8 gene. It is expected to disrupt RNA splicing. Variants that disrupt the donor or acceptor splice site typically lead to a loss of protein function (PMID: 16199547), and loss-of-function variants in ERCC8 are known to be pathogenic (PMID: 29572252).
- This variant is present in population databases (rs774047625, gnomAD 0.003%).
- Disruption of this splice site has been observed in individual(s) with Cockayne syndrome (PMID: 16865293).
- This variant is also known as IVS4+1G>A.
- ClinVar contains an entry for this variant (Variation ID: 550005).
- Algorithms developed to predict the effect of sequence changes on RNA splicing suggest that this variant may disrupt the consensus splice site.

- In summary, the currently available evidence indicates that the variant is pathogenic, but additional data are needed to prove that conclusively. Therefore, this variant has been classified as Likely Pathogenic.

GALT, Exon 1, c.-119_-116del (Non-coding), heterozygous, Benign (reportable variant)

- This variant occurs in a non-coding region of the GALT gene. It does not change the encoded amino acid sequence of the GALT protein. This variant is unique to the D2 allele and is also known as the Duarte variant.
- This variant is present in population databases (rs142496102, gnomAD 8%), including at least one homozygous and/or hemizygous individual. The c.-119_-116del variant is the most common galactosemia variant (PMID: 19904210).
- Compound heterozygosity for the Duarte allele and a pathogenic galactosemia variant (termed Duarte variant Galactosemia, DG) results in approximately 14-25% of normal GALT enzyme activity (PMID: 25473725, 25681083) and causes elevations of the metabolites found in galactosemia. DG may trigger a positive galactosemia newborn screening or abnormal biochemical test results but does not require dietary intervention (PMID: 30593450, 30593448) and does not cause the significant clinical consequences of classic galactosemia (PMID: 30593450, 31160755). A homozygous c.-119_-116del variant alone (DD) can have mildly reduced GALT enzyme activity but is insufficient to cause metabolite accumulation and is considered clinically benign (PMID: 24718839, 25473725).
- ClinVar contains two entries for this variant (Variation ID: 140570, 25111).
- Algorithms developed to predict the effect of variants on protein structure and function are not available or were not evaluated for this variant.
- Experimental studies have shown that this variant affects GALT enzyme activity (PMID: 11286503, 11479743, 19224951).
- For these reasons, this variant has been classified as a Benign reportable variant.

PKHD1, Exon 61, c.10637del (p.Val3546Alafs*22), heterozygous, PATHOGENIC

- This sequence change creates a premature translational stop signal (p.Val3546Alafs*22) in the PKHD1 gene. It is expected to result in an absent or disrupted protein product. Loss-of-function variants in PKHD1 are known to be pathogenic (PMID: 19940839).
- This variant is present in population databases (rs770461067, gnomAD 0.003%).
- This premature translational stop signal has been observed in individuals with autosomal recessive polycystic kidney disease (PMID: 11919560, 19940839, 27752906).
- ClinVar contains an entry for this variant (Variation ID: 279874).
- For these reasons, this variant has been classified as Pathogenic.

Residual risk

No carrier test can detect 100% of carriers. There still remains a small risk of being a carrier after a negative test (residual risk). Residual risk values assume a negative family history and are inferred from published carrier frequencies and estimated detection rates based on testing technologies used at Invitae. Methods

- Genomic DNA obtained from the submitted sample is enriched for targeted regions using a hybridization-based protocol, and sequenced using Illumina technology. Unless otherwise indicated, all targeted regions are sequenced with $\geq 50\times$ depth or are supplemented with additional analysis. Reads are aligned to a reference sequence (GRCh37), and sequence changes are identified and interpreted in the context of a single clinically relevant transcript, indicated in the Genes Analyzed table. Enrichment and analysis focus on the coding sequence of the indicated transcripts, 20bp of flanking intronic sequence, and other specific genomic regions demonstrated to be causative of disease at the time of assay design. Promoters, untranslated regions, and other non-coding regions are not otherwise interrogated. Exonic deletions and duplications are called using an in-house algorithm that determines copy number at each target by comparing the read depth for each target in the proband sequence with both mean read-depth and read-depth distribution, obtained from a set of clinical samples. Markers across the X and Y chromosomes are analyzed for quality control purposes and may detect deviations from the expected sex chromosome complement. Such deviations may be included in the report in accordance with internal guidelines. Variants are reported according to the Human Genome Variation Society (HGVS) guidelines. Confirmation of the presence and location of reportable variants is performed as needed based on stringent criteria, using one of several validated orthogonal approaches (PubMed ID 30610921). Sequencing is performed by Invitae Corporation (1400 16th Street, San Francisco, CA 94103, #05D2040778). Confirmatory sequencing is performed by Invitae Corporation (1400 16th Street, San Francisco, CA 94103, #05D2040778).

The following additional analyses are performed if relevant to the requisition. For GBA the reference genome has been modified to mask the sites of polymorphic paralog sequence variants (PSVs) in both the gene and pseudogene. For CYP21A2 and GBA, if one or more reportable variants, gene conversion, or fusion event is identified via our NGS pipeline (see Limitations), these variants are confirmed by PacBio sequencing of an amplicon generated by long-range PCR and subsequent short-range PCR. In some cases, it may not be possible to disambiguate between the gene and pseudogene. For GJB2, the reportable range includes large upstream deletions overlapping GJB6. For HBA1/2, the reference genome has been modified to force some sequencing reads derived from HBA1 to align to HBA2, and variant calling algorithms are modified to support an expectation of 4 alleles in these regions. HBA1/2 copy number calling is performed by a custom hypothesis testing algorithm which generates diplotype calls. If sequence data for a sample does not support a unique high confidence match from among hypotheses tested, that sample is flagged for manual review. Copy number variation is only reported for coding sequence of HBA1 and HBA2 and the HS-40 region. This assay does not distinguish among the $\alpha 3.7$ subtypes, and all $\alpha 3.7$ variants are called as HBA1 deletions. This assay may not detect overlapping copy gain and copy loss events when the breakpoints of those events are similar. For FMR1, cytosine-guanine-guanine (CGG) triplet repeats in the 5' untranslated region (5' UTR) of the FMR1 gene are detected by triplet repeat-primed PCR (RP-PCR) with fluorescently labeled primers followed by capillary electrophoresis. Reference ranges: Normal: <45 CGG repeats, intermediate: 45-54 CGG repeats, premutation: 55-200 CGG repeats, full mutation: >200 CGG repeats. For alleles with 55-90 triplet repeats, the region surrounding the FMR1 repeat is amplified by PCR. The PCR amplicons are then processed through PacBio SMRTBell library prep and sequenced using PacBio long read technology. The number of AGG interruptions within the 55-90 triplet repeat is read directly from the resulting DNA sequences.

However, in rare situations, single-exon copy number events may not be analyzed due to inherent sequence properties or isolated reduction in data quality. 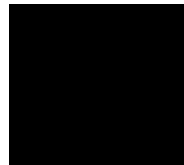

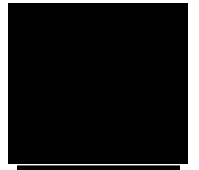

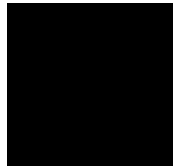
